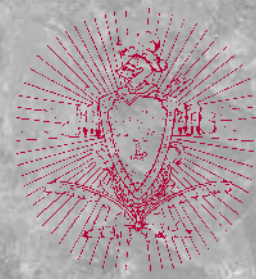

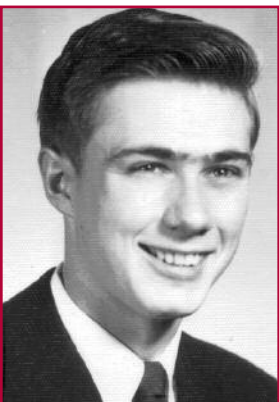

ALUMNUS PERSONIFIES PIKE SPIRIT THROUGH DECADES OF SERVICE

Key Figure In Miami, Oxford Community, and Most Certainly Delta Gamma Alumnus Spotlight — Hal Jasper '49

Hal Jasper '49 is a well-known figure in the Oxford community, though he is best known to more than 1,500 Delta Gamma alumni as Dodd Hall Inc.'s long-time treasurer.

Hal first came to Miami University in 1949, from Cleveland, Ohio, and earned his B.S. in

accountancy in 1952. As a student, he met his future wife, BJ, at a Lutheran student function and, in August 1951, the two were married. They lived in "Vet Ville" from 1951 to 1954, with their first son, Steve, joining the family in 1952.

After graduation, the dean of the Business School offered Hal a graduate teaching assistantship. The next year, C. Rollin Niswonger, chairman of the accounting department, asked Hal to accept a position as an instructor in accountancy for the following three years (1953-56.) The couple's second son, Scott, arrived in 1955.

Hal then applied for and received a pre-doctoral Ford Foundation Fellowship at the University of Illinois at Urbana-Champaign from 1956 until 1958. Timothy, the third son, was born in 1957. Hal then taught accounting at U of I for one year. Their daughter, Tamara, was born in 1959.

In the spring of 1959, Hal accepted an appointment as an assistant professor of accountancy at Arizona State University. During the summer of 1959, Dr. Niswonger asked Hal to return to Miami instead of going to Arizona State. Dr. Niswonger had a special one-year program that required him to leave Oxford, as he'd accepted an

appointment as a visiting professor at Arizona State. Hal and his wife and their four children returned to Oxford, Ohio. Hal stayed put at Miami, teaching accounting for 40 more years, finally retiring in 1999. He is now a professor emeritus.

Also in 1959, Hal rekindled his spirit of PKA brotherhood upon his return to Miami, volunteering to be financial and chapter advisor for Delta Gamma. His trusteeship began about the same time. It was only in the autumn of 2004 that he stepped down from his position as treasurer of Dodd Hall, though he still maintains an active role on the board. It's a rare event for Hal to miss a trustees meeting, even after an astounding 46+ years of service. It is very understandable, then, that he and BJ have been guests of honor for the Delta Gamma Alumni Association's reunions held the past two years for more than 200 brothers and their wives.

Over the years, Hal has been involved with many collegiate and civic committees, just a few of which include:

- ▶ Past MU faculty representative to NCAA, MAC, and Central Collegiate Hockey Association
- ▶ MU Student Disciplinary Appeals Board

- ▶ Past Treasurer, Oxford NAACP
- ▶ Presidential Task Force on Intercollegiate Athletics

He has also received numerous awards/honors for his efforts in the community and campus. Those include:

- ▶ 1966 Dr. F. B. Joyner Alumnus of the Year Award Recipient
- ▶ 1987 Oxford Citizen of the Year

- ▶ 2001 Recipient Bishop Distinguished Achievement Medal
- ▶ Hal Jasper Annual Award (given to the varsity athletic team—men or women—that gave the most service to the school and community during the previous year)
- ▶ The Stoddard Hall lounge is named The Hal Jasper room
- ▶ 1990 Outstanding Accounting Educator in Ohio
- ▶ The Hal Jasper Award is given annually to the outstanding alumnus most giving in time and energies to the Delta Gamma Chapter

Hal and BJ continue to live in Oxford, Ohio. Along with their four children, they have seven grandchildren, most of whom are in the Dayton and Cincinnati areas, as well as South Carolina. Hal is now retired, which has not lessened his heavy load of community and campus service. When he is not in one committee meeting or another, Hal enjoys sports but especially playing tennis and softball (fast and slow pitch).

If there is one person who personifies the Pike spirit of $\phi\phi\kappa\alpha$, one person who could be called Mr. Delta Gamma, that man would be roll #99, Hal Jasper. Thank you for all your selflessness, your tireless assistance, your spirit, your dedication, and your seemingly endless contributions of time and money throughout the past five decades. You have truly left Delta Gamma, Miami, and Oxford a much better place.

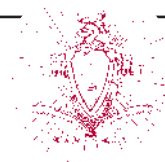
